SALARY DEDUCTION METHOD

General and Associate Memberships Only

Statement of Assignment Authorization:

I hereby assign to JCAA my interest and rights with respect to salary or wages for services that may hereafter become payable to me by the Jefferson County School District (hereinafter the "District") to the extent of \$45 monthly for General Members and \$22.50 monthly for Associate Members.

I hereby designate JCAA my agent to collect said monthly amount from the District and to apply said monthly amount to satisfy my annual JCAA dues obligations. I authorize the District to deduct the above monthly amount from my salary or wages and transmit the same to JCAA. In the event of my termination or retirement from the District, I further understand that said dues will only be collected up to the month when I leave the District's employ.

This authorization and assignment shall remain in continuous effect, without the need for renewal each fiscal year, unless and until revoked by me in writing delivered to the JCAA office.

In the event the amount of annual dues is changed, upon the approval of the JCAA Board, the amount to be transmitted to JCAA by the District and the amount to be collected by JCAA from the District shall be correspondingly changed.

The Jefferson County Administrators Association (JCAA) is a professional association for educational leaders in the Jefferson County Public Schools (Jeffco) District. JCAA is incorporated in the state of Colorado to;

- **Support administrators through representation, networking and professional growth.**

JCAA is governed by a board of 30 elected from and by members. The board is composed of officers and articulation representatives.

JCAA is many things – it is the voice of leaders in Jefferson County. It is a group with common vision and objectives. It is also a place where administrators can speak their minds knowing they are with like-minded people – it is a “safe” place, a refuge.

JCAA is a group interested in growing and learning – whether your interest is in mentoring or being mentored, JCAA provides connection with many of Jefferson County’s most experienced leaders. Collegial Conversations, Workshops, Socials and Professional Development events are chances to rub shoulders and bounce ideas off Jeffco’s brightest leaders.

JCAA is a group interested in producing balanced educational legislation. JCAA is about two-way communications. The association communicates outwardly through a variety of email updates, through area reps at articulation meetings, and through the association staff. Members are encouraged to communicate formally and informally through Issues Forums, surveys, listening sessions, through area representatives and through the association staff.
